# Work-Saving Methods Now **Optional for Lodge Secretaries**

The Grand Master has approved a plan to eliminate many outmoded practices required of all Lodge Secretaries.

In making this announcement, Bro. W. LeRoy McKinley, Grand Master, said: "It is my desire to reduce as much

#### Visitors' Register

To accomplish his objective, the Grand Master first authorized the use of a permanent, bound Visitors' Register. The visitor must write his name. the name, number and location of his Lodge and the date.

In addition, each visitor will be required to fill in the usual visitor's ticket or slip and present it to the Tyler before being admitted into the Lodge Room.

If a Lodge desires to use a loose-leaf Visitors' Register, it must be submitted to the Grand Master for his approval prior to its use.

With the use of the Visitors' Register, the Secretary will not be required to write the names of visitors in the Minute Book.

#### **Members'** Attendance

A permanent card system for recording the attendance of Lodge Members is now authorized. This method consists of a separate 4" x 6" or 5" x 8" card for each member of the Lodge, arranged in alphabetical order in a suitable, portable file.

Each member will fill in the usual member's ticket or slip and present it to the Tyler prior to entering the Lodge Room. After the Lodge has been opened, the Tyler can arrange the members' tickets or slips in alphabetical order, and then stamp, or write in ink, the date of the meeting on the cards of those members who are present.

The Lodge may select someone other than the Tyler to record the date. These cards must be retained as a permanent Lodge record.

The above methods eliminate the necessity of writing the names in the Minute Book, but the old system can be continued if the Lodge desires.

The Secretary must continue to record in the Minutes the separate number of Members and Visitors present at each meeting.

#### **New Minute Book**

The Grand Master also authorized the use of a suitable, loose-leaf Minute Book for those Lodges which desire to have their Minutes typed rather than written.

The Minute Book must have a substantial, hard cover with flexible posts and a mechanical locking device which can be permanently locked when the Minute Book is filled.

#### **Auditing Committee Reports**

The Grand Master said it is only necessary to copy the Receipts and Expenditures from the Report of the Auditing Committee in the Minute Book, provided a copy of the complete Report for each year is filed in a hardcover binder, with substantial metal posts, and retained as a permanent Lodge record.





Bro. Aaron B. Ilson, a member of Oakland Lodge No. 535, Pittsburgh, spiritual leader of Temple Sinai, and Bro. Pinchos J. Chazin, a member of Shekinah Lodge No. 246, Philadelphia, spiritual leader of Temple Sholom, are the new Chaplains.

Bro. Edward A. Hagel, of Lodge No. 343, was appointed District Deputy Grand Master for the 5th Masonic District, vice Bro. Andrew O. Friedrich.

Bro. Paul Thomas Feeser, of Lodge No. 270, was appointed District Deputy Grand Master for the 11th Masonic District, vice Bro. Virgil C. Scott.

Bro. Ilson, a Pittsburgh community leader, has been very active in mental health work and serves as Chaplain of the Psychiatric Institute of Pittsburgh.

Bro. Chazin, also very active in community projects in the Philadelphia area, served as a chaplain in the United States Air Force during World War II.

## Ahiman Rezon Now Permits Transfer and Protects Standing

Grand Lodge approved a new system for transfer of membership within this Iurisdiction at the Quarterly Communication on December 5, 1962.

Under the new plan, a member is not required to actually resign his membership in a Pennsylvania Lodge until after he has been accepted by another Lodge in this Jurisdiction to which he seeks membership.

To accomplish this, Grand Lodge had to approve a change to Section 2 of Article XX of The Ahiman Rezon, which reads as follows:

"Section 2. When a Brother petitions for membership only, he must present a Lodge Certificate under the seal of the Lodge of which he was last a member, or furnish other satisfactory evidence that he is in good Masonic standing, and that he is not a member of any Lodge,"

The above was amended to read:

"Section 2. When a Brother Master Mason desires to change his membership from one Lodge to another within this Jurisdiction, he shall present a notice of his desire and a conditional resignation in writing to the Secretary of his Lodge, setting forth therein the Lodge in which he desires to become a member and his resignation from his present Lodge conditioned upon his acceptance in the Lodge of his choice.

"If presented at a Stated Meeting it shall be read in open Lodge at that meeting, and, if presented between meetings, at the next Stated Meeting whereupon, if his dues are paid for at least six months in advance, and there are no charges pending against him, there shall be issued to him, under seal of the Lodge, a Transfer Certificate, in form provided.

"This Transfer Certificate shall be deposited with his petition in the Lodge which he desires to join and shall be regarded as the necessary documentary evidence to accompany a Petition for Membership.

"If elected, the Secretary of the petitioned Lodge shall immediately notify the Lodge of which the petitioner is a member and his resignation shall become effective and his membership therein shall cease as of the date of said election.

"If at the expiration of six months from the date of issuance of the Transfer Certificate the Petitioner has not been elected into membership in the petitioned Lodge, the Transfer Certificate shall become null and void and the Petitioner shall remain a member of in his membership record by reason of cation on December 27, 1962.

"When a Brother petitions for membership only, he must present a Lodge Certificate under the seal of the Lodge of which he was last a member, a Transfer Certificate as herein provided, or furnish other satisfactory evidence that he is in good Masonic standing and, except when a Transfer Certificate is submitted, that he is not a member of any Lodge.'

### Our Work 'Sublime From Its Simplicity'

Albert G. Mackey, in his Encyclopedia of Freemasonry, has seen it fitting and proper to use the very words of a Past Grand Master of Pennsylvania, Brother Richard Vaux, as pertaining to the Ritualistic and Lodge Work of Lodges in Pennsylvania.

In the spoken language no synonyms are permitted. In the ceremonial no innovations are tolerated. In the Ritual no modern verbiage is allowed."

The Grand Master is appointing District Chairmen to assist the Grand Lodge Committee on Masonic Culture.

In announcing the new plan, Bro. W. LeRoy McKinley, Grand Master, pointed out:

"The Committee on Masonic Culture has increased the emphasis being placed on our excellent Masonic Culture program.

"I also know that it is not practical to burden District Deputy Grand Masters with additional duties.

"However, if we can accelerate the emphasis of the Culture program, the result will be better Masonic education for candidates of our Lodges."

He said the sole duty of the District Chairmen will be to promote and coordinate the programs of the Committee on Masonic Culture in District Lodges.

Although the District Chairmen will be under the supervision of District Deputy Grand Masters, they actually will be serving under the direction of the Committee on Masonic Culture, headed by Bro. Charles H. Nitsch, R. W. Past Grand Master.

Bro. Nitsch and his committee will provide the training and materials for the District Chairmen.

The Committee on Masonic Culture has a three-part program that has been designed to create well-informed Masons.

Plan One involves a series of four booklets to be given to the candidate, with the first being presented before the candidate receives his Entered Apprentice Degree, and one of the others after each degree.

The second step involves a series of eight pamphlets developed for the Lodge Committee on Masonic Culture. the type of activities in which the chair-The material in these booklets is to be men will be involved. given to the candidate orally, prior to his initiation and as he progresses through the three degrees.

The third step is geared to the man that is "Facing the East." This booklet is sent to all Senior Wardens months before they are elected to the East.

This booklet gives the prospective Worshipful Master suggestions on how to do a good job, including suggestions on leadership and planning.








The Traditional designed Masonic Hall has 100 permanent seats.

mittee on Masonic Temples, Halls and Lodge Rooms. His committee will give Lodges all the assistance possible.


This committee also has copies of suggested charters and by-laws for a Masonic Hall Association. They also can be obtained by contacting the Grand Master's Office.

The four basic plans for new Lodge rooms include four contrasting eleva-

tions - Modified Colonial, Colonial, Suburban and Traditional. Any one of the four elevations can be adapted to any one of the four different size Lodge Halls.

In all cases, the Lodge Hall is designed as a minimum requirement. The size of the various structures varies to suit the needs of the Lodge membership.

Modified Colonial: Designed for Lodges with approximately 150 members. It is considered the smallest basic type desirable for the Masonic work to be performed properly. All facilities are on the main floor, with the Lodge Room seating 72 members in permanent seats. Included in the design are



a secretary's room, lounge, social room, kitchen, storage room and heater room. Estimated basic cost is \$45,000 to \$50,000.

Colonial: Designed for Lodges with approximately 200 to 350 members. The Lodge Room is designed to contain 100 permanent seats. It has the same general floor plan as the Modified Colonial unit except that all rooms are larger. The estimated cost is \$65,000 to \$75.000.

Suburban: Designed for Lodges with approximately 500 to 600 members. The Lodge Hall is designed to contain 150 permanent seats. The plan is similar to the Modified Colonial and Colonial units except that all rooms are larger. The estimated cost is \$85,000 to \$100,000.


Traditional: Designed on two floor levels, one over the other, for Lodges with approximately 200 to 350 members. The estimated cost is \$100,000.

Lodges interested in obtaining further information on the new Masonic Hall plans, as listed in this paper, can obtain a complete brochure by writing to the Grand Master's Office.

It is suggested that Lodges obtain the brochure, then determine the desired size of the building need, before requesting copies of detailed plans and specifications.


The Saturday sessions will start at 8:30 a.m. and continue until 12 noon, and then from 1:00 p.m. to 3:30 p.m.

# 2nd-3rd-4th Petitions Possible

At or after the expiration of six months from the date of his final rejection on the first petition, the rejected petitioner may present a second petition for initiation and membership in the Lodge that rejected him.

Such petition shall be subject to the same proceedings by the Lodge as in the case of the first petition, except Lodge will attend Stated Meetings that it cannot be withdrawn until a ballot has been taken and the petitioner approved. A second ballot cannot be taken on a second or subsequent petition.

At or after the expiration of one year from the rejection on a second petition, the petitioner may apply in writing to the same Lodge that rejected him to permit him to present a third On receipt of this application, the Lodge shall order same to lie over for one month, and notice shall be given to all members that at the next Stated Meeting the Lodge will act on said

At the next Stated Meeting the Worshipful Master shall direct the Secretary to read the application, and when the same is read the Worshipful Master shall direct a ballot to be taken thereon. If the ballot is not unanimous, it ends all action by the Lodge in the case for one year, after which the petitioner may again apply, when the application shall be subject to the same pro-

If the ballot is unanimous, the petitioner may present a third petition, subject to the same Rules and Regulations governing the proceedings in cases of the first and second petitions for initiation and membership. If the petitioner is again rejected, this rejection ends all action by the Lodge in the case.

The Ahiman Rezon makes no provisions for the presentation of fourth petitions for initiation and membership. Requests for permission to receive such petitions must be made of the Grand Lodge by resolution of the Lodge.

This request is to be accompanied by letters, setting forth the facts, and giving good and sufficient reasons and asurances why it is believed that the objection does not now exist. Without such explanation the Grand Master will not permit the request to go before the Grand Lodge.

When a petition for initiation and membership is received by a Lodge from one who has been rejected in this Jurisdiction at least ten years prior to the presentation of such petition, all action upon the same shall be subject to the direction of the Grand Master.
