## PATRIOTIC PILGRIMAGE Great Day for Freemasonry

It may have been the largest public display of Freemasonry ever witnessed by a community in Pennsylvania.

The celebration brought an estimated 25-thousand persons to the borough and when the last group of massed colors had passed by; when the final salute had been taken from the reviewing stand; when the last of 54-hundred marchers crossed the finish line, Gettysburg had witnessed the largest masonic parade ever held in the state of Pennsylvania.

The PATRIOTIC PILGRIMAGE, the Grand Lodge of Pennsylvania's tribute to state and nation in honor of the 300th anniversary of the founding of the Commonwealth and the 250th anniversary of the birth of Bro. George Washington, was an unqualified success.

The almost constant rain that plagued every Saturday for weeks prior to June 26 disappeared as if on cue. No rain was going to fall on this parade!

The celebration was everything the officers of the Grand Lodge had hoped it would be. It was advertised as an opportunity to be grasped by all members of the masonic family and virtually every masonic-related organization in the state took part.

The sea of purple and blue collars that marched through 1.9 miles of the streets

of Gettysburg was followed by units in all colors representing the York Rite and Scottish Rite bodies, the Shrine Temples, the Tall Cedars, Grottos and the youth organizations.

Color was everywhere. Clowns were everywhere. Children were everywhere. The spirit of patriotism was evident everywhere.

It was an event so distinctive that all description seems pale in light of what actually occurred.

Six pages of Patriotic Pilgrimage photographs are contained on pages four through nine of this issue of *The Pennsylvania Freemason* in an attempt to create an adequate record of a great day for Freemasonry in Pennsylvania.

#### **Bro. A. T. Moore Awarded Franklin Medal**

Bro. Arthur T. Moore, former Assistant to the Grand Master, now retired, has been awarded the Pennsylvania Franklin Medal in recognition of his distinguished service to the Grand Lodge of Pennsylvania.

Bro. Moore, who retired in 1976 after more than 17 years as Assistant to the Grand Master, became the eleventh recipient of the medal since its introduction in 1979.

The presentation was made by Bro. Samuel C. Williamson, R.W. Grand Master, during the March Quarterly Communication held in Philadelphia.

The Pennsylvania Franklin Medal was introduced in September of 1979 when then Grand Master, the late Bro. Walter P. Wells, announced the first presentations were to be made to the living R.W. Past Grand Masters.

That group included Bros. Richard A. Kern, W. LeRoy McKinley, Earl F. Herold, Robert E. Deyoe, John K. Young, Hiram P. Ball, W. Orville Kimmel, Rochester B. Woodall and John L. McCain.

The last time a recipient for the medal was chosen was in December of 1979 when it was presented, again by Bro. Wells, to Bro. Stanley F. Maxwell, Most Worshipful Past Grand Master of the Grand Lodge of Massachusetts and Sovereign Grand Commander, Supreme Council, Ancient Accepted Scottish Rite, Northern Jurisdiction.

The Pennsylvania Franklin Medal is struck in solid, 18 karat gold in the likeness of Bro. Benjamin Franklin who twice served as Grand Master of the Provincial Grand Lodge of Pennsylvania, in 1734 and 1749. The likeness was prepared by renowned sculptor, Donald DeLue.

Those who receive it, if not already members of the Grand Lodge of Pennsyl-

vania, automatically become honorary members.

Bro. Moore, who worked as an editor for the Pittsburgh Sun-Telegraph (a Hearst newspaper no longer publishing) before he came to the Grand Lodge, was made a mason in Tyrian Lodge No. 612 and later became a warrant member of Forbes Trail Lodge No. 783.

He is a member of Excelsior Mark Lodge No. 216, Media Chapter No. 284 and Philadelphia—St. John's Corinthian Commandery No. 4, Knights Templar.

A member of Syria Temple, AAONMS, Pittsburgh and the Scottish Rite Valley of Pittsburgh, he was coroneted an honorary thirty-third degree mason in 1977.

He currently serves as an Aide to the Grand Master.

Bro. Moore lives with his wife, Peggie, at 4339 50th Terrace South, Maximo Moorings, St. Petersburg, Fla. 33711.

#### Fund Drive at 25% of Goal

#### Contributions to Youth Foundation Now Tax Deductible

The Pennsylvania Youth Foundation has been recognized as a charitable institution by the Internal Revenue Service.

Charitable status allows those participating in the current fund drive to deduct their contributions to the foundation from federal income taxes.

Charitable status also provides that gifts, bequests, legacies, etc., to the foundation are deductible for federal estate and gift tax purposes as provided in the internal revenue code.

The drive for funds to establish the financial base of the foundation has reached a little more than 25 per cent of its goal of \$500,000 with more than \$126,000 collected as of the first week in July.

A special computer program has been devised to keep track of all contributions so that each is properly recorded and receipt is acknowledged. The program reveals some interesting trends in the pattern of giving.

The Pennsylvania Youth Foundation, to date, is being supported by individuals whose contributions make up more than \$42,000 of the total; by the lodges, adding almost \$40,000, and by other masonic organizations who have contributed more than \$21,000.

A total of \$6,120 has already been received from the 1982 travel program and another \$11,000 has been earned but not yet received.

The R.W. Grand Master, Bro. Samuel C. Williamson, retains his confidence that the fund drive will meet its goal. "The fact the entire masonic family is taking part is heartening," he said, adding, "particularly when you realize that 25 per cent of the goal has been obtained with contributions by less than two per cent of the membership."

The Grand Master's statement reflects those statistics pointing to contributions to date from 3,115 of more than 211,000 masons in the state and participation by just 52 of the 581 lodges in the jurisdiction.

"When the other 98 per cent of the membership and the other 529 lodges find the opportunity to participate, 1 am sure we will more than meet our goal," Bro. Williamson said.

In the meantime, the fledgling foundation is beginning to show a track record of achievement. For example, DeMolay, in comparing the number of initiates gained in the first five months of 1982 as compared to the same period in 1981, has documented an 18 per cent increase.

New members have joined chapters in Crafton (Fidelity) and Charleroi (Monongahela Valley) where little activity was recorded in the past.

New chapters are being explored for the Hershey area and in Lehighton. There is considerable interest in restoring chapters in Bradford, Warren and Paoli.

Masonic organizations in Springfield and Norristown are hoping to become involved with existing DeMolay chapters in order to reverse a trend of declining membership.

The staff of the foundation had assisted the Grand Lodge Committee on Youth Activities in preparing the Patton campus for four Rainbow groups who conducted three-day "reward sessions" during the month of June.

The foundation also took an active part in greeting two groups of Job's Daughters who used the facilities at the Patton complex from July 18 through July 21.

Generally, the Pennsylvania Youth Foundation has dramatically increased the visibility of our masonic youth groups and has fired interest in our lodges and in all the appendant bodies in their activities.

The foundation was designed to help provide financial support, leadership and training for our youth. It is beginning to fulfill that mission.

It is expected fund raising activity will increase now that the call off for the summer months is coming to an end. A number of lodges and masonic bodies have been able to earn specific recognition for their support of the foundation.

The program devised to acknowledge contributions has received much favorable comment throughout the fraternity.

Each contributor receives a personal letter recognizing his gift. Contributions of \$500 or more are noted by the issue of a silver and pewter certificate while contributors of \$1,000 or more receive a specially struck bronze medallion imbedded in a four inch by eleven inch piece of walnut wood. (See photo this page and report on June Quarterly Communication.)

The Grand Master has authorized the use of lodge charity funds in support of the foundation. Individual contributions, large or small, are greatly appreciated.

## **Grand Master Issues Four New Decisions, Revises Another**

The R.W. Grand Master, Bro. Samuel C. Williamson, has issued four additional changes to the *Digest of Decisions*, bringing to 12 the number distributed thus far in 1982.

At the same time, a decision issued last February allowing the lodges to put their names and places of meeting on community signs has been revised to include an approved masonic symbol.

Bro. Williamson, noting that much of the instruction normally given the lodges is negative in character, that is, it states what cannot be done rather than what can, has been making a concerted effort to issue decisions that give the lodges greater freedom to engage in activities that will increase the visibility of the fraternity as a whole.

The latest decisions reflect that attitude.

The first of these, issued officially on April 22, changes Article LXXXIII, Section 3, page 126 of the *Digest of Decisions* as follows:

LXXXIII Printing and Publishing and Press Releases

"3. Advertisements and notices in newspapers, publications, radio and television stations of the time and place of meetings of the lodges is permitted so long as the advertisements and notices have the prior approval of the District Deputy Grand Master."

The second decision, also issued on April 22, came as the result of several requests from Past Masters who sought permission to wear Past Master's jewels when visiting other lodges.

The Ahiman Rezon and Digest of Decisions have, to this point, been concerned with the description of the Past Master's jewel and the manner in which it is to be worn on the left lapel or left breast pocket of the coat.

A fourth section has been added to Article XLVIII, page 63 as follows:

#### XLVIII Jewels

"4. The Past Master's jewel may be worn in visiting any lodge in this jurisdiction."

The third decision of the new group was issued on May 23, again in response to a number of suggestions that officers of the lodge who conduct funeral services be allowed to wear regalia, as well as others who asked that the dress for the masonic funeral service be clarified or standardized.

#### LX Masonic Clothing and Dress

"2. The normal dress for masonic funerals shall be dark clothes, dark necktie, black shoes, white gloves, apron and collar and jewel for participating lodge officers, or those serving in their stead. It is recommended that attending brethren wear dark clothes, aprons and white gloves, if possible. This is in accordance with that part of the Ahiman Rezon dealing with charges, ceremonies and forms; in this case, Masonic Funerals, page 151. However, if a lodge elects to have a lodge service in accordance with page 147 of the Ahiman Rezon, masonic dress shall be worn by lodge officers, if available. If a visit to the funeral home, church or cemetery follows the lodge room service or lodge meeting, masonic dress (including collars and aprons) may be worn by lodge officers."

In consequence of the above decision, certain portions of the *Ahiman Rezon* on pages 151 and 154 were changed to accommodate the provisions of the new decision.

Decision four, issued on May 28, was designed to give the lodges the opportunity to display art on the walls of the lodge room so long as it has significance and does not offend.

#### LVIII Lodge Rooms

"5. Charters, certificates, banners and other like insignia relating to York Rite and Scottish Rite masonry, or any other order or organization whatsoever, cannot appear on the walls or elsewhere in a lodge room while the lodge is meeting whether the lodge room has been dedi-

cated to Freemasonry or not. Such insignia must be removed from the lodge room before the lodge meets. If it cannot be removed, the lodge cannot meet there. No exception has ever been taken to the existence, curtained back, of the veils of the Royal Arch Chapters in lodge rooms. where they exist. This is the only exception which proves the rule. and the exception cannot be extended. The Grand Lodge is supreme in all that pertains to ancient Freemasonry and its lodges and members must all conform to its usages and customs.

This regulation is not meant to discourage the lodge from adorning its walls with framed paintings, portraits and the like providing the display has been approved by resolution of the lodge. The practice of displaying grouped photographs of Past Masters, memorials to deceased Past Masters, etc. in the anteroom of the lodge room, rather than in the lodge room itself, is encouraged."

The revision relates to a decision issued on February 19 and concerns Article LXI on page 87.

LXI Masonic Emblems, Names and Signs

"8. With the approval of the Grand Master, the names of the lodges and their places of meeting may be made a part of those signs posted along highways and streets at the entrance to communities to denote the existence of service clubs and other organizations.

The only masonic symbol that may appear on the signs is the square and compasses in a form approved by the Grand Master. A copy of the design to be used can be obtained from the office of the Grand Master."

All 12 decisions issued by the Grand Master to date are now being reproduced in page form to be permanently added to the *Digest of Decisions*.

## Special Youth Program to Precede September Quarterly

A special youth program will precede the September Quarterly Communication of the Grand Lodge of Pennsylvania to be held in the Masonic Temple, Philadelphia on Wednesday, September 1.

The R.W. Grand Master, Bro. Samuel C. Williamson, has invited the elected heads of all three masonic youth organizations—DeMolay, Rainbow for Girls and Job's Daughters—to address the Grand Lodge during the special program scheduled for Corinthian Hall at 6:30 p.m.

A Past Grand Master of the International Order of DeMolay has also accepted an invitation to attend the quarterly.

Bro. C. C. Faulkner, Jr., now serving as Senior Grand Warden of the Grand Lodge of Indiana, will speak to the Grand Lodge during the actual communication which will begin promptly at 7:00 p.m.

The program is designed to permit the Grand Lodge to offer the same recognition to the youth organizations that is recommended to the lodges by Article 58 of the *Digest of Decisions* issued by the Grand Master during his inaugural address:

"Lodges are encouraged to invite the Order of DeMolay, Order of Rainbow for Girls and Job's Daughters to provide programs at the conclusion of any meetings of the lodge."

The youth organization officers are being invited to appear before the Grand

Lodge meeting in order to accommodate other scheduling requirements.

The Grand Master expects a large number of Master Masons will attend the meeting to demonstrate support of the youth organizations.

A special dinner will be made available at 4:45 p.m. to all those who make reservations by sending to the office of the Grand Master the coupon that accompanies this article.

There is no charge for the dinner, but space restrictions require that reservations be made on a first request basis and cut off when they reach 1,000 persons, the limit imposed by the amount of dining space in the Masonic Temple.

Upon receipt of your coupon, a ticket will be sent to you. Because an overflow crowd is expected, only those persons with tickets will be admitted to the dining rooms.

DeMolay will be represented at the special youth program by Eric Ullom, State Master Councilor, Associated Chapters, Order of DeMolay of Pennsylvania.

He will be accompanied by Bro. Thomas R. Labagh in his capacity as Executive Secretary of the state organization and Bro. John L. McCain, R.W. Past Grand Master, in his capacity as Deputy of the International Supreme Council, Order of DeMolay, and Executive Officer in Pennsylvania.

The International Order of Job's Daughters of Pennsylvania will be represented by Miss Kelli Morris, Miss Job's Daughter of Pennsylvania.

Miss Morris will be accompanied by Mrs. Betty Deiter, Grand Guardian of the International Order of Job's Daughters of Pennsylvania.

Rainbow will be represented by the Grand Worthy Advisor of the Pennsylvania Grand Assembly, International Order of the Rainbow for Girls. (The young lady who will hold the post in September had not yet been elected when this report was written.)
