Concerning the cover...

The helicopter view of the Masonic Homes at Elizabethtown that is featured on the cover of this issue of The Pennsvlvania Freemason is one of 78 views contained in a new slide presentation concerning the Homes that will soon be made available to the lodges and other interested groups.

A montage of other views within the presentation is contained in the centerfold on pages six and seven.

Professionally prepared, the slide presentation from first view to last covers a period of just eight minutes, 57 seconds.

Narrated by the Assistant to the Grand Master, Bro. Melvin S. Mundie, the script was prepared as an independent part of the total production as was the photography itself and the background music.

The cassette tape contains an electronic pulse to move the slides automatically during the narrative.

The slide presentation was commissioned by the Grand Lodge Committee on Masonic Homes to give the viewer a sense of the philosophy behind the operation of this greatest of masonic charities while projecting the feeling of care and protection provided its quests.

It is designed to stimulate discussion and increase support for the Masonic Homes at Elizabethtown.

The means to distribute 150 kits of the slide presentation is now being prepared.

The kits contain a slide carousel, cassette tape narrative and script, as well as a list of equipment needs and instructions for their use.

The person who presents the program should be well versed in the rules. regulations and procedures concerning application and admission to the Masonic Homes at Elizabethtown.

The program is also suitable for nonmasonic audiences.

June Quarterly Communication to be Held in Pittsburgh

The June Quarterly Communication of the Grand Lodge of Pennsylvania will be held in Pittsburgh using the facilities of three neighboring buildings in the Oakland section of the city - the Masonic Temple, Syria Mosque and Soldiers and Sailors Hall.

The actual Grand Lodge communication will take place at 7:00 p.m. on Wednesday, June 1 in Soldiers and Sailors Hall.

The hall is being used in order to increase the seating capacity for the meeting and to eliminate a number of problems in the movement of people when the Grand Lodge last met in Pittsburgh in June of 1977.

Grand Master Samuel C. Williamson has asked the Senior Grand Warden, Carl W. Stenberg, Jr., to serve as general chairman for the event.

Bro. Stenberg is already well into the planning for a 5:00 p.m. dinner for masons, their families and friends, as well as a program for entertaining the ladies while the Grand Lodge is in session.

A later program, featuring name entertainers, is being planned following the Grand Lodge communication. The evening will conclude with dancing.

The Grand Master has a specific entertainment in mind, but the entertainers are reluctant to commit themselves at this early date. The exact program will be announced as soon as it is confirmed.

The day's activities will be scheduled as follows:

5:00 p.m. Grand Masters Dinner

Dinner will be served in the dining rooms in the lower level of Syria Mosque as well as in the dining areas of the Masonic Temple.

Tickets, at \$12.50 per person, will be made available on a first request basis with the Mosque dining rooms being filled first.

Syria Mosque will seat 1,500 persons comfortably and the Masonic Temple will seat 900. A total of 2,400 tickets will be distributed through the District Deputy Grand Masters and the lodges in western Pennsylvania. A number of tickets will also be available through the office of the Grand Master in Philadelphia.

Samuel C. Williamson Begins Second Year as Grand Master

Bro. Samuel C. Williamson has been elected and installed to a second year as Right Worshipful Grand Master of the Lodge of Free and Accepted Masons in Pennsylvania.

Elected to the highest office in Freemasonry during the December Quarterly Communication, Bro. Williamson was duly installed during the Annual Grand Communication held in Philadelphia on Monday, December 27, 1982.

Grand Master Williamson, a resident of Pitcairn Borough, east of Pittsburgh, is an executive of U.S. Steel currently serving as superintendent of the Chemicals Department at the Clairton Works.

The Grand Master's executive ability has been very evident in his first year as Grand Master. He has authored many decisions that have served to increase the involvement of family members in masonic activity while making the fraternity in general more visible to the public.

His program has been and will continue to be dedicated to the youth organizations as evidenced by the establishment of the Pennsylvania Youth Foundation.

He has made good his early promise to improve the relationship of the Grand Lodge to all other masonic bodies as evidenced by the highly successful Patriotic Pilgrimage involvement of all segments of the masonic family.

The following is the entire text of the Grand Master's state of the craft address as given during the Annual Grand Communication:

Brethren, I deeply appreciate the honor you have again conferred upon me — the opportunity to serve this Grand Lodge for another year as your Grand Master.

It is customary for the Grand Master to give the first year accounting of his stewardship, a sort of State-of-the-Craft message to relate some of the highlights of the year.

One year ago I said, "Nothing is as permanent as change and that progress demands change". Following that theme, your Grand Lodge Line Officers, working as a team, have made many changes which have been well recieved by the members of the Craft. This team effort by your Grand Lodge Line Officers assures a continuity of programs and decisions.

The major thrust of the changes may be divided into three groups.

First – Our Lodge meetings – which for too long have been bogged down with custom and to a large degree excluded our families and our Masonic related youth groups.

Decisions have been issued permitting the elimination of the reading of the minutes in detail. Our families may be present at the social activities on the night of any meeting of the lodge. Also, our Masonic related youth groups (DeMolay – Rainbow and Job's Daughters) may be present on the night of the meeting of the lodge.

Reports indicate many lodges are having family nights and entertainments on their stated meeting nights. Our Masonic youth groups have been included in many lodge programs. Several lodges have expressed a desire to sponsor these youth activities.

I am certain these changes, along with others, will be beneficial to our lodges and ultimately result in more membership participation.

Second - Lodges have been authorized to participate in Masonic dress, in any appropriate public ceremony, with the approval

of the Grand Master. This Grand Master has been pleased to approve several such appearances. The posting of signs at the entrance to communities showing the name, location of the lodge and carrying an approved square and compasses symbol has been authorized to let those entering the community know that Masons are present.

Advertisements and notices in newspapers, publications, radio and television stations of the time and place of meetings of the lodge has been permitted.

I have already indicated my belief that we must now, more than ever before, conduct ourselves visibly as Freemasons; that we ought to increase our exposure to the community, thereby letting our friends and neighbors know that we are Masons and give them the opportunity to learn what we stand for.

On Saturday, June 26, your Grand Lodge sponsored a Patriotic Pilgrimage to Gettysburg when over 5000 Masons and Masonic related youth groups, representing the entire Masonic family, paraded in that community.

Saturday, July 31, your Grand Lodge sponsored a barge display at the Three Rivers Regatta in Pittsburgh to again let the public see and learn about our great fraternity. This activity also included all the Masonic family working together.

The brochures, *Should I Ask* and *Freemasonry A Way of Life*, have been made available to each subordinate lodge and the members have been encouraged to give them to their non-Mason friends and associates who should know the story of our fraternity.

Remember, what is important to our communities is what Masonry appears to be. We must become visible in our communities. Third – An active youth program has been established with the formation of the Pennsylvania Youth Foundation under the direction of Bro. Thomas R. Labagh. Representatives from all the Masonic Bodies are serving on its board. All of our Masonic related youth groups and their advisors have made extensive use of this facility. I am happy to report to you that we are seeing concrete results from this effort.

Our DeMolay membership is showing a gain of 29% over last year. We expect to constitute a new chapter in March of 1983 under the sponsorship of State College Lodge No. 700. Several chapters have been reactivated and DeMolay is on the move.

Rainbow and Job's Daughters report increased activity and interest in new assemblies and bethels. Job's Daughters will constitute a new bethel in Camp Hill on January 22, 1983. Many Lodges have had youth programs this year and have invited our young people to provide programs. This activity is again recommended for the coming year.

At the September Quarterly Communication of your Grand Lodge, an historical first occurred. The presiding officers of our youth groups, along with their adult advisors, were part of the procession prior to the opening of the Grand Lodge. Each of the young people then addressed the Brethren.

Prior to the opening of the Grand Lodge for the December Quarterly, the DeMolay *Flower Talk* was presented by DeMolay Randy Riggle, the State *Flower Talk* Champion. 1 am pleased to report to you that this young man has just petitioned for membership in the Masonic Lodge in his community.

The renovations to the Patton facility are moving on schedule; the anticipated completion date remains June 1, 1983. Upon its completion, we will have one of the finest Masonic Training Centers in these United States. This youth activity program is receiving wide acclaim; we have received inquiries from many Grand jurisdictions requesting information regarding its activities. This year over 1400 young people have attended a program at this facility.

To date, a large number of lodges and other Masonic Bodies have contributed to the foundation's Endowment Fund. While we have not reached our goal of \$500,000.00 we are approaching it and currently have recieved \$307,887.00.

Favorable comments have been received from Juvenile Authorities including Judges and Social Workers throughout the country, regarding our sponsorship of *Today's Delinquent*, the digest which is published jointly by the Grand Lodge and the National Center for Juvenile Justice. This activity will be continued and expanded during the coming year. *Quarterly Communications*

Attendance has steadily increased at our Quarterly Communications. The June Quarterly held at Harrisburg was the largest ever with over 2300 brethren in attendance.

The March and September 1983 Quarterlies will be held in Philadelphia and the June Quarterly in Pittsburgh. The Annual Grand Communication will be held in Hershey.

Your Grand Lodge officers participated in laying the cornerstones and dedicated the lodge rooms of Elk Lodge No. 379 in Ridgeway on May 22, Cromwell Lodge No. 572 in Orbisonia on August 21 and Summit Lodge No. 312 in Ebensburg on September 25.

It is with sorrow that I recall the loss of two Past Grand Masters, Bro. Richard A. Kern on July 26 and Bro. W. LeRoy McKinley on October 5. On a personal note, your Grand Master made one hundred eleven trips to Philadelphia to conduct Grand Lodge business; visited 44 lodges; made 19 trips to the Masonic Homes; 39 visits to other Masonic Bodies (York Rite, Scottish Rite, Shrines, Grottos and Tall Cedars), and 13 trips outside of the jurisdiction. In addition, I attended 16 DeMolay functions, 4 Rainbow and Job's Daughters meetings, and 5 meetings of the Pennsylvania Youth Foundation Board of Directors, having traveled over 90,000 miles.

At the February meeting of the Conference of Grand Masters' of North America, I was honored by being elected Chairman of that Conference and will preside until February of 1983. This activity required an additional six trips outside our jurisdiction.

All through this report, I have not particularly thanked the Grand Lodge team for their hard work and dedication. The many activities and programs could not have been completed without the dedication of the Grand Lodge Elected officers, Past Grand Masters and District Deputy Grand Masters.

In addition, the appointed Grand Lodge officers, Committees on Masonic Homes, Finance, Culture, By-Laws, Trustees; the Assistant to the Grand Master, and the employees of the Grand Lodge have given everything they have been asked for and more.

No man can hope to carry out the responsibilities of Grand Master alone. I have been fortunate to have a dedicated team to carry out these responsibilities.

As we face the new year, it is my hope that we can continue to move our Grand Lodge ahead. I must admit, however, that I do have some concern.

We seem to be satisfied to carry on as we have for years in the past, following the same pattern-offering nothing new – and giving little in the way of suggestions and directions.

Today, we are in an era of enlightenment, we face the year 1983 and not 1731. We must respect the past, but plan for the future with new ideas.

Recently, many of you concluded long election procedures in your lodge. Effective today, the following decisions are issued:

1. For those offices that are uncontested, the Lodge may elect by voice vote.

2. Officers reelected need not be installed as long as they continue in that office.

An Amendment will be presented at the June 1983 Quarterly Communication to eliminate the installation of the R.W. Grand Secretary and R.W. Grand Treasurer when reelected.

I have today signed five new Decisions – each designed to prepare the way for constructive change or to clarify existing procedure.

A new section will be added to the Digest of Decisions under the general title, *Youth.* The First decision in that new section is one that authorizes the Worshipful Master "to appoint a worthy member, not necessarily a Past Master, as a representative to the Pennsylvania Youth Foundation." The second decision permits the name of the lodge representative to the foundation to be listed on the back page of the lodge notice, if room permits. If room is not available on the last page, any other convenient space in the notice can be used.

Also in keeping with our stated obligation to our young men and women as the future of this fraternity, I have added the (Continued on page 9)

Freemason Mailed from Philadelphia

With the advent of computerized mailing and the five and nine-digit zip code systems, it follows that the old, tried and true pigeon hole method of separating mail would fade away.

Fortunately for Bro. John Bittner, who has traveled from his home in Lemoyne to Elizabethtown to apply his sorting expertise to the mailing of every issue of The Pennsylvania Freemason since 1974, the eventual automation of the magazine's mailing process coincided with his own decision it was time to retire.

Bro. John has retired before, several times, and at the age of 82 he figures he has the right to do so again.

He was a mail clerk for the Railway Mail Service for 40 years, from 1922 to 1962.

A man who knows every zip code in the country has little trouble finding gainful employment so he spent the next 11 years sorting mail for the Department of Revenue in Harrisburg, from 1962 to 1973, before deciding to give his fraternity a hand.

Mrs. Vera Greiner, who served as the manager of the Distribution Office at the Masonic Homes at Elizabethtown until the mailing operation was recently moved to the Masonic Temple in Philadelphia, describes John Bittner as "faithful, dedicated, a humorist and humanitarian who was an inspiration to know and work with."

Bro. Robert M. Grieve, Masonic District "J". Bro. Grieve, a Past Master of Progress Lodge No. 609 in Philadelphia, served as District Deputy Grand Master for 6 years.

Bro. Joseph Gentile, 11th Masonic District. Bro. Gentile, a Past Master of Pottsville Lodge No. 730 in Pottsville, served as District Deputy Grand Master for 5 years.

Bro. Joseph R. Borden, 17th Masonic District. Bro. Borden, a Past Master of Tioga Lodge No. 373 in Tioga, served as District Deputy Grand Master for 5 years.

Grand Master Issues Five Additions to Digest of Decisions

The R.W. Grand Master issued five additions to the Digest of Decisions during the Annual Grand Communication on December 27

Bro. Samuel C. Williamson said in his state of the craft message that each of the decisions was "designed to prepare the way for constructive change or to clarify existing procedure."

Noting the commitment of the Grand Lodge to the improvement and growth of the youth organizations (as evidenced by the establishment of the Pennsylvania Youth Foundation), the first decision adds a 96th article to page 141 of the digest.

Designed to help maintain the spirit of participation and dedication to youth activities among the members and the lodges, the new article provides:

- 1. The Worshipful Master is authorized to appoint a worthy member, not necessarily a Past Master, as a representative to the Pennsylvania Youth Foundation. 2. The name of the lodge representative
- to the Pennsylvania Youth Foundation may be listed on the back page of the lodge notice, if possible, or in any other convenient space in the notice.

The appointee will serve as liasion between the foundation and the lodge and will issue regular reports of foundation activities to the lodge.

The second new decision continues the effort to do everything possible to assist our youth by adding the Pennsylvania Youth Foundation to the list of youth organizations whose activities can be carried in the lodge notice.

Matters relating to the Pennsylvania Youth Foundation have been added to page 82 of the digest as item 15 of section 13 under article 57.

The lodge notice itself is the subject of the third decision.

The content of the lodge notice has been carefully restricted by masonic law in order to protect its function as the trestleboard for the business of the lodge.

The increasing costs of printing and postage, combined with the need to improve the ability of the lodge to communicate with others as well as its members, however, has prompted the Grand Master to allow the use of printed inserts as separate additions to the lodge notice.

The following was therefore added to article 57 as a section 14 to be added to page 82 of the digest:

Decision four is designed to eliminate the confusion that sometimes occurs during the annual meetings of the lodges as to who is eligible to be present at the installation of a Worshipful Master or in Passing to the Chair.

The following is to be added as section 14 to article 75, page 114 of the digest:

The final decision issued by the Grand Master on December 27 is the result of repeated requests by members in response to two earlier changes.

Pennsylvania Youth Foundation to the list of those youth organizations whose activities can be noted in the lodge notice. Accordingly, a new item 15 has been added to Section 13 of Article 57 of the Digest.

And while on the subject of the lodge notices - the ever increasing costs of printing and mailing have caused us to consider removing some of the restrictions as to its content. Most four page lodge notices are filled to the last line and leave no room for any information other than that required of a trestleboard in the administration of the lodge.

And so, I have authorized the use of inserts to the lodge notice, as additions to and not as part of the notice, as means of communicating information about the families of members, of their friends, and of lodge and district social functions. As with the lodge notices themselves, the inserts will require the approval of the District Deputy Grand Master prior to publication,

Another change in the Digest of Decisions will help to increase the

14. Lodges are permitted to use inserts in lodge notices, not a part of the notice, for information on families, friends, lodge and district functions and other similar items of interest to the members, providing such inserts have the prior approval of the District Deputy Grand Master,

14. A member who has received the Word of the Chair in a recognized masonic body is eligible to be present at the installation of a Worshipful Master or in Passing to the Chair.

On February 19, 1982, Decision 61, Masonic Emblems and Signs, Section 8, page 87 was issued granting to the lodges the ability to include their names and addresses on signs at the entrance to their communities.

On July 16, 1982, the decision was modified as the result of repeated requests to include an approved masonic symbol (the square and compasses), the design for which can be obtained from the office of the Grand Master.

The Grand Master has received numerous requests in recent months to expand the use of masonic emblems by allowing them to be displayed on items of clothing, prompting him to add a section 9 to article 61 as follows:

9. Members are permitted to use masonic emblems, including the names and numbers of the lodges, on appropriate articles of clothing such as windbreakers, jackets, caps, etc.

The changes in the Digest of Decisions have already been sent to the Worshipful Masters of the lodges. Individual pages of the digest will be reprinted in the near future to reflect the changes.

visibility of the fraternity - to allow the public display of fraternal membership, A section has been added to Article 61 regarding Masonic emblems, names and signs. Members are now permitted to wear articles of clothing such as caps, jackets, windbreakers, etc. on which are represented Masonic emblems and the names and numbers of the lodges.

The final new decision in this group is one that will clarify the confusion that occurs at times at the Annual Meetings of the lodges as to who is eligible to be present at the installation of the Worshipful Master or in Passing to the Chair. This decision provides that "Any brother who has recieved the Word of the Chair in a recognized Masonic Body is eligible to be present at the installation of a Master or in Passing to the Chair."

There is one other change I have requested that is not in the form of a decision, but is one that will require an amendment to the Ahiman Rezon. (Continued on page 10)

In Memoriam

Bro. W. LeRoy McKinley, R.W. Past Grand Master, at 88

Editor's note - The following eulogy was delivered at the December Quarterly Communication of the Grand Lodge of Pennsylvania by Bro. John K. Young. R.W. Past Grand Master and Grand Counsel:

Bro. W. LeRoy McKinley, Right Worshipful Past Grand Master of the Grand Lodge of Pennsylvania, a resident of Bryn Mawr, died Wednesday, October 5, 1982 at 88 years of age.

Born on September 23, 1894 in Philadelphia to John Elwood McKinley and Esther Armstrong Clarke, he was educated in the elementary schools in Philadelphia; at Brown Preparatory School, and graduated from the University of Pennsylvania in 1918.

He practiced law in the City of Philadelphia and held memberships in the Philadelphia, Pennsylvania and American bar associations.

Having served in World War I, he was a former county commander of the American Legion. He served as a legal officer with Philadelphia's Selective Service Board during World War II and the Korean War.

Raised a Master Mason in Frankford Lodge No. 292 on June 26, 1917 where his father, grandfather and five uncles had been active masonically, he served as Worshipful Master of the lodge in 1926.

Bro. McKinley was a member of Siloam Royal Arch Chapter No. 226; a warrant member of Frankford Commandery No. 92, and held memberships in the Scottish Rite bodies of the Valley of Philadelphia. He recieved the 33° on September 24, 1958.

Bro. McKinley was elected Right Worshipful Junior Grand Warden of the Grand Lodge of Pennsylvania in 1955 and served as the Right Worshipful Grand Master in 1962 and 1963.

He was appointed as general counsel for the Grand Lodge in 1955 and served in that capacity until 1970.

The Past Grand Master is survived by a son, Bro. J. Warren McKinley. three grandchildren and a brother.

"It is necessary, however, that we review vesterday in order that it may serve as a foundation and a helpmate for tomorrow."

Travel Program Benefits Youth Foundation

Grand Master Samuel C. Williamson stated in his inaugural address in December of 1981 that all returns from the travel program to be sponsored by the Grand Lodge of Pennsylvania during 1982 would be applied to the fund drive to endow the Pennsylvania Youth Foundation.

The process of absorbing the lodges into other districts in the Philadelphia area was enhanced by the fact that all the lodges meet in the Masonic Temple in

Each of the districts to which the lodges were assigned also has lodges that meet in the Masonic Temple.

As a further consequence to the realignment, Masonic District J will be renamed Masonic District I in order to maintain the chronological order of the districts.

The number of lodges in the state has been reduced by mergers caused for the most part by economic conditions. As the costs to maintain the lodges increase, those in poorer financial condition seek to associate with stronger lodges.

A lesser number of lodges seek merger when they are unable to attract new leadership or membership.

In either event, it appears the city or urban lodges suffer the problem to a greater extent than the rural lodges.

The Grand Master has asked the Deputy Grand Master, Bro. William A. Carpenter, and the Senior Grand Warden. Bro. Carl W. Stenberg, Jr., to research the current alignment of the districts and offer suggestions for changes in the future.
