The Masonic Library & Museum maintains and preserves the majestic Masonic Temple in Philadelphia, a National Historic Landmark renowned for its beauty, architectural mastery and historical significance. Welcoming tens of thousands of visitors each year, it showcases more than 30,000 artifacts, including precious relics from our nation's founding, as well as priceless works of art and other treasures from Philadelphia and around the world. It also operates a fully functional research and circulating library, conducts genealogical research and hosts educational programs and cultural activities for members and the public. In addition, the charity preserves monuments throughout Pennsylvania, including: the Friend to Friend Masonic monument in Gettysburg, the National Memorial Arch in Valley Forge Park and the George Washington at Prayer statue at Valley Forge.

Masonic Village serves more than 3,000 seniors across Pennsylvania. Masonic Village residents enjoy peace of mind knowing they will be cared for, regardless of their health conditions or financial abilities. Masonic Village also provides home and community-based services, including hospice, palliative care, home health care and home care, and support Freemasons and their widows, veterans and first responders through the Masonic Outreach program.
